

# St. Luke the Evangelist Catholic School Tuition and Tuition Assistance 2023 - 2024



Tuition for registered,

Parishioner Rate: 1<sup>st</sup> Child \$4,400  
Parishioner Rate: 2 Children \$8,400  
Parishioner Rate: 3 Children \$12,050  
Non-Parishioner: 1<sup>st</sup> Child \$6,500  
Non-Parishioner: 2 Children \$12,600

If the student is from another Catholic parish without a catholic school, the family will pay the "parishioner" rate and their sponsoring parish will subsidize the remainder. For non-parishioners, the parishioners of St. Luke's will cover the remainder of the cost as part of our hospitality ministry.

Registration Fee: \$150 per student  
FACTS Tuition Fee: \$50 per family per year

*\*Tuition now includes textbook and technology fees.  
Tuition is evaluated annually.*



It is the responsibility of the parents/guardians to tithe to their Church and support the school development and fundraising activities as both the parish and school are investing in the Catholic education of your child.

The tuition partially covers the total expense. The school board, administration and finance council work diligently to keep expenses at a minimum. In order to meet the financial obligations of the parish it is imperative for families to stay current on their tithing contributions.

## Catholic Tuition Organization

Catholic Tuition Organization (CTO) is funded through a tax credit offered by the state of Iowa. This scholarship is available to any St. Luke's School family. Applications and instructions are made available during Catholic Schools week at the end of January. Families who are eligible apply online at [www.fairapp.com](http://www.fairapp.com) and pay a processing fee.

Applications need to be completed by the designated date, and first round awards are finalized by the end of May. If there are additional funds available, applications will be accepted until July 31<sup>st</sup>. Visit [www.ctoiowa.org](http://www.ctoiowa.org) for more information.

## St. Luke the Evangelist Guardian Angel

The Guardian Angel scholarship is available to any St. Luke's School family. Families who do not receive CTO will receive first priority for available funds. The form is available at St. Luke's School and should be returned to the office. Applications are available any time during the year. Awards are finalized when individual family scholarship package is completed.



## 529 Plans

One of the 2017 Tax Cuts and Jobs Act changes allows distributions from 529 plans to be used to pay up to a total of \$10,000 of tuition per beneficiary (regardless of the number of contributing plans) each year at an elementary or secondary (k-12) school of the beneficiary's choosing. Please consult your tax advisor to determine documentation requirements.
